#### 1. Introductions

**i.** Frank Bohlen, a physical oceanographer from UConn Avery Point, speaking to us about the Niantic River Amtrak Bridge construction.

### 2. Frank Bohlen

- i. Frank Bohlen works on fine grain sediment transport and has done work with tidal "choking." He's done a little work on the Niantic River as a consultant for Amtrak. Bob DeSanto has also done some work with this and both of them can give you contacts to help with questions that neither of them can answer.
- ii. New bridge will be 60-80' from the old bridge. A groin will be put in to stabilize the beach. Frank sees no negative effect on the interior of the bay and it will provide recreation and will stabilize the channel. The flow won't change with the new groin. As a physical oceanographer, he feels there will be no long term change in flow and will not create any tidal "choking."
- iii. There will be some changes to the sedimentation patterns, but in turn, it would make it more stable. Frank also doesn't know the extent of the dredging that will happen in the channel. With the new bridge, there will be less eddying and still plenty of flow. The key is to keep an eye on the progress of the construction since there always seems to be a difference between the ideal plan and what is actually implemented on the ground.
- **iv.** Frank seems to think that the old bridge will probably be removed and there will be a new walkway in place.

### 3. Presentation: Bob DeSanto

i. Bob has been in contact with the Town of East Lyme. He's looking in to putting together a Niantic River Certification Program that homeowners can apply for. He will put together the materials/criteria of water quality indicators that will be used to determine if homeowners meet the requirements to have this certification. Several members of the group went and we were able to speak to some high school students about the Niantic River. Also, Sarah has sent out a questionnaire to the superintendents of the four school districts and all of them have responded and are very eager to participate with the questionnaire. They seemed very positive about our group and are excited to hear more!
